**ONE DAY WAIVER FOR MINOR

WAIVER AND RELEASE OF LIABILITY**

In consideration of Swings-N-Things Family Fun Park furnishing services and/or Equipment to enable me to participate in paintball games, I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death, or other ailments that could cause disability; (c) these risks and dangers may be caused by negligence of the owners, employees, officers or agents of the field: the negligence of the participants, the negligence of others, accidents, breeches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of the field or by any other person, act or situation.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify it's owners, agents, officers, and employees from any and all claims, actions or losses for bodily harm or injury, property damage, wrongful death, loss of services to otherwise which may arise out of my use of paintball equipment or my participation in paintball activities, specifically understand that I am releasing, discharging and waiving any claims or actions against Swings-N-Things Family Fun Park that may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers, employees of the field or other participants.

In the event that a parent or guardian is not present to sign the waiver and release of liability, a responsible adult may also if they have been given permission by the parent or legal guardian of the minor top accompany their child.
